INVITATION TO BID FOR
Procurement of one unit Generator set and 2 unit set
Chainsaw

1. The *Municipality of Manay*, through the *General Fund* ¹ intends to apply the sum of *Two Hundred Thousand* being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of one unit generator set and 2 unit of chainsaw. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Manay* now invites bids for *procurement of one unit generator and 2 units chainsaw, at Manay, Davao Oriental.*² Delivery of the Goods is required *10- 15 days after receipt of Purchase Order* . The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from *Municipality of Manay* and inspect the Bidding Documents at the address given below during *8:00 am to 5:00 pm*.

¹ In the case of National Government Agencies, the General Appropriations Act and/or continuing appropriations; in the case of GOCCs, GFIs, and SUCs, the Corporate Budget for the contract approved by the governing Boards; in the case of (LGUs, the Budget for the contract approved by the respective *Sanggunian*. (Section 5(a), R.A. 9184)

² A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.



5. Bids must be delivered to the address below on or before *August 22, 2012 at 3:00 pm*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found.**

Bid opening shall be on August 23, 2013 at 3:00 pm the Mayor's Conference Hall. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

6. The Municipality of Manay reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
