A complete set of Bidding Documents may be purchased by interested Bidders on November 4, 2013 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of *One Thousand Pesos(P1,000.00)*.

Bids must be delivered to the address below on or before November 11, 2013 at 4:00 pm. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB**.

Bid opening shall be on November 12, 2013 at 10:00 o’clock am at *the Mayor Conference Hall*. Bids will be opened in the presence of the Bidders’ representatives who choose to attend at the address below. Late bids shall not be accepted.

The *Municipality of Manay* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
