INVITATION TO BID FOR
Concreting of Farm to Market Road

1. The Municipality of Manay, through the Department of Agriculture, ¹ intends to apply the sum of
 - a. Five Hundred Sixty Six Thousand One Hundred Nineteen and Seventy Five Centavos being the Approved Budget for the Contract (ABC) to payments under the contract for Concreting of Farm to Market Road from Jct. Nat'l. Highway-Buawan Road;
 - b. One Million Six hundred Sixty Eight Thousand Eight Hundred Seven and Sixty Three Centavos being the approved budget for the contract of Concreting of Farm to Market Road from Jct. Nat'l. Highway –Lower Napo Road and ;
 - c. One Million Six Hundred Ninety Eight Thousand Six Hundred Sixty and Forty Seven Centavos being the Approved Budget for the Contract (ABC)for Concreting of Farm to Market Road from Purok Buan-Anibongan Road .

Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of Manay now invites bids for the contract of
 - a. Concreting of FMR from Jct. Nat'l. Highway=Buawan Road located at the Brgy. Central , Manay, Davao Oriental. Completion of the Work is required 47 CD from issuance of Notice to Proceed;
 - b. Concreting of FMR from Junction Nat'l. Highway-Lower Napo Road located at Brgy. Zaragoza, Manay, Davao Oriental. Completion of the work is required 79 CD from issuance of Notice to Proceed; and

c. Concreting of FMR from Purok Buan-Anibongan Road located at Brgy. Holy Cross, Manay, Davao Oriental.² Completion of the Work is required 81 CD from issuance of Notice of Proceed.

Bidders should have completed, within ten(10) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

(i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from Municipality of Manay and inspect the Bidding Documents at the Office of the Chairman during 8:00 am to 5:00 pm.

A complete set of Bidding Documents may be purchased by interested Bidders on November 26, 2013 from the Office of the BAC Chairman and upon payment of a nonrefundable fee for the Bidding Documents in the amount of One Thousand (P 0,000.00 Pesos).

The Municipality of Manay will hold a Pre-Bid Conference on December 3, 2013 at the Mayor’s Conference Hall At 10:00 o’clock in the morning, which shall be open to all interested parties who have purchased the Bidding documents.

3. Bids must be delivered to the Office of the BAC Chairman, 2nd Floor, A. Moralizon St, Central, Manay, Davao Oriental on or before , December 13, 2013. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause Error! Reference source not found..

² A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

Bid opening shall be on December 16, 2013 at the Mayor's Conference Hall. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

4. The Municipality of Manay reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
