INVITATION TO BID

1. The *Municipality of Manay*, through Trust Fund (DSWD-BUB PROJECTS 2015) intends to apply the sum of *One Hundred Eighty One Thousand Two Hundred Fifty Pesos* being the Approved Budget for the Contract (ABC) to payments under the contract for *Procurement of Hardware/Agri Supplies*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Manay* now invites bids for procurement of Hardware/Agri Supplies under Purchase Request # 401-2016-02-0051, at *Manay, Davao Oriental*.¹ Delivery of the Goods is required 10 to 15 days after receipt of Purchase Order. 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines,

and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- Bids must be delivered to the address below on or before April 18, 2016. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB**.

Bid opening shall be on April 19, 2016 at 10 :00 o'clock in the morning at the *Mayor's Conference Hall* . Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
