5. Bids must be delivered to the address below on or before April 18, 2016 at 4:30 o’clock in the afternoon. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB**.

Bid opening shall be on April 19, 2016 at 10:30 o’clock in the morning at the *Mayor’s Conference Hall* . Bids will be opened in the presence of the Bidder’s representatives who choose to attend at the address below. Late bids shall not be accepted.
