## INVITATION TO BID

1. The *Municipality of Manay*, through Trust Fund (DSWD-BUB PROJECTS 2015) intends to apply the sum of *Eighty Nine Thousand Five Hundred Pesos* being the Approved Budget for the Contract (ABC) to payments under the contract for *Supply and Delivery of various commodities*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Manay* now invites bids for *Supply and Delivery of various commodities* under *Purchase Request #401-2016-02-0050 at Manay, Davao Oriental*.<sup>1</sup> Delivery of the Goods is required 15 days after receipt of Purchase Order. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from *Municipality of Manay* and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm.
