**INVITATION TO BID FOR  
SUPPLY AND DELIVERY OF MEDICINES  
MEDICAL, DENTAL & LABORATORY SUPPLIES**

1. The Municipality of Manay , through the General Fund 2017 intends to apply the sum of One Million Two Hundred Ten Thousand Three Hundred Twenty Six Pesos being the Approved Budget for the Contract (ABC) to payments under the contract for supply and Delivery of Medicine, Medical, Dental & Laboratory Supplies . Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Municipality of Manay now invites bids for supply and Delivery of medicine, medical, dental & laboratory Supplies. Delivery of the Goods is required within 10 days upon receipt of Purchase Order. Bidders should have completed, within *[insert relevant period]* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
  - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from the Municipality of Manay.
5. A complete set of Bidding Documents may be acquired by interested Bidders on April 20, 2017 and upon payment of Two Thousand Five Hundred Pesos.
6. The Municipality of Manay will hold a Pre-Bid Conference on April 27, 2017 at 10:00 o'clock in the morning at the Mayor's Conference Hall, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before 9:00 o'clock in the morning. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found..**

Bid opening shall be on May 9, 2017 at 10:00 o'clock in the morning at the Mayor's Conference Hall. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Municipality of Manay reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
