Procurement will be conducted through open competitive bidding procedures in accordance with RA 9184 and its Implementing Rules and Regulations (IRR).

Prospective bidders should have experience in undertaking a similar project within the last 2 years with an amount of at least 50% of the proposed project for the bidding and have key personnel and equipment (owned, leased or under purchase) available for the prosecution of the project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

(i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from Municipality of Manay and inspect the Bidding Documents at the Office of the Chairman during 8:00 am to 5:00 pm.

A complete set of Bidding Documents may be purchased by interested Bidders on **July 3, 2017** from the Office of the BAC Chairman and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Five Thousand Pesos (P 5,000.00 Pesos).

The Municipality of Manay will hold a Pre-Bid Conference on **July 7, 2017** at the Mayor's Conference Hall At **10:00 o'clock in the morning**, which shall be open to all interested parties who have purchased the Bidding documents.

Bids must be delivered to the Office of the BAC Chairman, 2nd Floor, A., Moralizon St, Central, Manay, Davao Oriental on or before **July 18, 2017**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB.

Bid opening shall be on **July 18, 2017 @ 10:30 o'clock in the morning** at the Mayor's Conference Hall. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Municipality of Manay assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of the bid and reserves the right to accept or reject any bid to annul the bidding process, and to reject all bids at any time without any liability to the affected bidder or bidders.
