**INVITATION TO BID FOR ONE UNIT VEHICLE**

1. The *Municipality of Manay*, through the *General Fund 2017* intends to apply the sum of *Two Million Pesos* being the Approved Budget for the Contract (ABC) to payments under the contract for the *Procurement of one unit brand new vehicle*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
  
2. The *Municipality of Manay* now invites bids for one unit brand new vehicle (4X4 LS-A AT, 4-DOOR WAGON, 4JJ1-TC (HI) (3.0 LITER) 4 CYLINDER IN LINE DOHC COMMON RAIL DIRECT INJECTION DIESEL ENGINE WITH VARIABLE GEOMETRY SYSTEM (VGS) TURBO INTERCOOLER, EURO 2 PER FACTORY SPECIFICATIONS, under the Office of the Municipal Mayor. Delivery of the Goods is required within 30 days from receipt of Purchase Order . Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
  
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.  
  

**(i) Select this paragraph if conditions (a), (c), and (d) under Section 23.4.1.2 of the IRR of RA 9184 do not exist:** Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
  
4. Interested bidders may obtain further information from the *Municipality of Manay* and inspect the Bidding Documents at the address given below during *8:00 o'clock in the morning to 5:00 o'clock in the afternoon*.
  
5. A complete set of Bidding Documents may be acquired by interested Bidders on April 28, 2017 from the address below *and upon payment of Two Thousand Five Hundred Pesos for the Bidding Documents*.
  
6. The *Municipality of Manay* will hold a Pre-Bid Conference on *May 5, 2017 at 10:00 o'clock in the morning* at the *Mayor's Conference Room*, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before *May 17, 2017* . All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on May 17, 2017 at 10: o'clock in the morning at the *Mayor's Conference Room*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The *Municipality of Manay* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
