

INVITATION TO BID

1. The *Municipality of Manay*, through Trust Fund (Calamity Fund) intends to apply the sum of One Million Three Hundred Thirteen Thousand Three Hundred Pesos being the Approved Budget for the Contract (ABC) to payments under the contract for the procurement of one unit brand new vehicle (pick up type). Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Municipality of Manay* now invites bids for the procurement of one unit brand new vehicle, pick up type ,4x2 (A/T-EL) automatic Transmission, 2.5 L Diesel Engine, four (4) cylinder inline (DOHC), 16 valve CRDi, Turbo with intercooler, water cooled, 5 link with stabilizer rear suspension with factory installed calsonic airconditioning system, in dash CD stereo with AM/FM tuner (MP3), power steering, front and rear seatbelts, dual airbag, anti-lock system(ABS) 255/70R16 alloy magwheels with complete standards tools and equipment, *at Manay, Davao Oriental*.¹ The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.
4. Interested bidders may obtain further information from *Municipality of Manay* and inspect the Bidding Documents at the address given below during 8:00 am to 5:00 pm.

A complete set of Bidding Documents may be purchased by interested Bidders on January 8, 2018 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Two Thousand Five Hundred Pesos (P 2,500.00).

The *Municipality of Manay* will hold a Pre-Bid Conference on January 15, 2018 at *the Mayor’s Conference Room at 10:00 am*, which shall be open to all interested parties.

¹ A brief description of the type(s) of Goods should be provided, including quantities, location of project, and other information necessary to enable potential bidders to decide whether or not to respond to the invitation.

5. Bids must be delivered to the address below on or before January 29, 2018. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB**.

Bid opening shall be on January 29, 2018 at 10:00 o'clock in the morning at the Mayor's Conference Room. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

6. The *Municipality of Manay* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
